Professional Experience

Frederick Community College: The College, located in Frederick, Maryland, is an hour northwest of Washington, DC and an hour west of Baltimore. The fall 2020 credit enrollment is 8690. The non-credit enrollment is approximately 5,550. The majority of the FCC credit students select transfer programs (71%), are female (59%), are Frederick County Residents (93%), and are 29 years of age or younger. Twenty-seven percent of College credit students identified themselves as first-generation. 11% of students take classes online (pre-Covid), more than 300 are Open Campus secondary school students, and the high school-based Dual Enrollment program enrollment exceeds 1000 students at all ten (10) of the Frederick County high schools.

Provost and Executive Vice President for Academic Affairs and CEWD: A member of the Senior Leadership Team and Chief Academic Officer. Responsible for providing leadership for the Arts and Sciences, Career Programs, Continuing Education and Workforce Development, Dual Enrollment/Open Campus Partnerships, Diversity, Equity and Inclusion, and the Center for Teaching and Learning, including Online Learning and Instructional Innovation, Writing and Tutoring Centers, Assessment Center, and Learning Commons. Highlights include:

- Developed and promoted a shared vision for innovation and excellence in teaching and learning for the College that resulted in the Academic Master Plan and the Diversity, Equity and Inclusion Strategic Plan. Both of these informed the Facilities and Information Technology Strategic plans.
 - Facilitated the successful merger of the Academic Affairs and Continuing Education & Workforce Development teams. The reorganization focused on improving student success and innovation.

- Provided oversight of quality, integrity and effectiveness of curricula, including the introduction of the Sign Language Interpreter Preparation and Cybersecurity credit and non-credit programs. Implemented five umbrella transfer majors – A.A. – Arts and Humanities; A.A. – Social Sciences; A.S. – STEM; A.A.S. – STEM Technologies; and A.A.S. – Emergency Management - to replace the General Studies major and facilitated a model for guided pathways. Upcoming: Physical Therapist Assistant (2021).
 - Provided leadership of the academic program review, student learning outcomes, and general

- education assessment. Introduced technology-based assessment process and increased faculty expertise through participation in the Outcomes Assessment Council and closing the loop.
- Developed the Academic Master Plan used to guide the direction and progress under the themes of Academic Excellence, Support and Infrastructure, Faculty and Staff Professional Development and Leadership, and Community Engagement and Economic Development. The Academic Master is updated annually.
 - Fostered innovation in teaching and learning which led to the creation of the Learning Commons, Prior Learning Assessment, and Open Education Resources (OER).
 - Introduced the annual three-day January Leadership Conferences for associate vice presidents, deans, directors, department chairs, institute managers, and office managers.
 - Revitalized the Global Education Program and the Global Learning Council chaired by the executive director of Diversity, Equity and Inclusion. Served as an assistant trip leader on a Global Scholars trip to Costa Rica.
 - Achieved significant expense reductions by base budget reallocations, review of hourly staff and adjunct faculty accounts, position elimination, and creation of new positions to update the workforce.
 - Implemented a review process for equipment purchases, including a justification related to student learning outcomes.
 - Revised the Faculty Appointment and Promotion Process to include college service and alternative professional development.
 - Participated in the development of 36 policies including Academic Standards, Assessment/Placement, Intellectual Property, Copyright, Complaint Policy for Students Policies and Procedures.
 - Managed effective and productive relationships between the College and senior members of the Frederick County Public Schools. The FCC/FCPS Partnership is responsible for the smooth implementation of Maryland's College and Career Readiness and College Completion Act. High school-based Dual Enrollment is a model program in Maryland.
 - Developed and implemented an Early College program where students simultaneously earn an associate's degree and high school diploma upon graduation.
 - Chaired the Maryland Council of Community College Chief Academic Officers. Responsible for several statewide higher education initiatives, including multiple measures for placement, Transfer with Success Act, and an annual conference on college completion strategies.
 - Received an \$1.6 million America's Promise grant from the U.S. Department of Labor for workforce development in computer and network programming as a part of the Capital Region Collaborative with Montgomery and Prince George's Community College.
 - Created pathways and internal articulation agreements between credit and non-credit programs in allied health and wellness, hospitality, culinary, and tourism, and ESL/ABE to college readiness.
 - Led the College through the COVID response, providing regular virtual situational briefings on the status of the virus within Frederick County, updates on regular campus operations and protocols, and the impact on instruction for faculty, staff, and students.

Montgomery College: A multi-campus organization, Montgomery College ranks on many *best of* lists for

community colleges in America. 170 countries are represented among the more than 30,000 credit students taking classes and earning degrees and certificates. The College also provides more than 4,200 offerings through Workforce Development and Continuing Education. The Takoma Park/Silver Spring Campus is the first Montgomery College campus (established in 1950) and serves an annual student enrollment of more than 7,500 FTE. Feature programs include the liberal arts – transfer, visual art and design, speech and performing arts, and social sciences programs.

Instructional Dean: Responsible for providing consistent and steady leadership of the Arts, Humanities, and Social Sciences division on the Takoma Park/Silver Spring campus and guiding collegewide programs, including the AELP (American English Language Program), the Montgomery College School of Art + Design (SA+D), and Cultural Arts Center. Highlights include:

- The division covers 25 different disciplines which serve the developmental, transfer, career, general education and instructional support needs of students.
- Managed the division office of 15 staff, 51 full-time and more than 140 part-time faculty. • Reviewed workloads, prepared budgets, approved expenditures, identified needs for hiring, supervised the hiring process, prepared and reviewed evaluations, and evaluated the effectiveness of the unit. The division contained two instructional support centers, The Writing and Reading Center and the Social Sciences Lab, which were on the cutting edge of technology use in student learning.
- Served as the acting Vice President and Provost for extended periods of time. Participated in upper level planning, purchasing, and advancement discussions.
- Represented management interests in staff union negotiations of AFSCME collective bargaining agreement and Labor Relationships Collaboration Committee.
- Regularly attended meetings to address and resolve collegewide issues, including governance, academic policies, and future directions for programs, courses, and personnel.
- Center for Teaching and Learning (2005-2011): Provided administrative leadership for faculty professional development through the Center for Teaching and Learning. The CTL sponsored fellowships, orientation workshops, technical support for classroom and online applications, and individual programs for new and seasoned faculty.
 - Perkins Grant (2004-2011): Responsible for the management of the College's Carl T. Perkins grant totaling \$539,369 to support 17 Career and Technical Education programs. My role was to oversee the application, monitoring and reporting processes collegewide to the Maryland State Department of Education. I recently coordinated a successful site visit required by the *Office of Civil Rights* to ensure that we are in compliance with the Title VI of the Civil Rights Act of 1964, Title IX of the Education Amendments of 1972, and Section 504 of the Vocational Rehabilitation Act of 1973.
- Formed a unique partnership with the BlackRock Center for the Arts, presented the Maryland Chautauqua each summer with the Maryland Humanities Council and served as a member of the Montgomery County Arts and Humanities Council.

Hudson County Community College: a comprehensive urban community college located across the Hudson River from Manhattan enrolling more than 6,000 students each semester in credit and non-credit programs. The college offers courses in Business and Social Sciences, Culinary Arts, English and Humanities, and Mathematics, Science, Technology and Allied Health. The North Hudson Center features bilingual and ESL programs.

Associate Dean of English and Humanities: One of four academic deans, I was responsible for executing the administrative tasks of the college's English and Humanities, English as a Second Language and basic skills writing and reading courses.

- Supervised more than 40 full-time faculty members, directors, and coordinators. • The division operated the Writing Center, Honors Program and Interdisciplinary Learning Communities, and opened a space to house the new theater and studio art programs. • Assistant Dean of Academic Affairs: With the Vice President for Academic Affairs, established the academic goals of the College, including supervising all evening, non-traditional and off-campus program offerings, monitoring all partnerships between the College, high schools, and upper division institutions, and determining appropriate action for students whose academic progress falls below the established criteria. Notable achievement includes the development of Liberty High School, an alternative Middle-College located on the campus.
- Managed the College's Perkins grant, learning resources center, tutorial center, distance learning and instructional labs.
- Graduate Intern: Collected, edited, and wrote campus policies for inclusion in a comprehensive policy manual for the Board of Trustees. Internship project included Personnel, Academic and Student Affairs, Administrative Services and Board of Trustees policies.

Prince George's Community College: serves a largely diverse population, enrolling more than 40,000 full and part-time students each semester. More than 5,000 noncredit courses, special programs and workshops were available through the college's Continuing Education curriculum. PGCC employed over 1,900 faculty, administrators, and staff, and maintained a total operating budget in excess of \$92,000,000.
